Sub: Announcement of the 42nd Post Graduate Diploma Course in Advanced Wildlife Management for Forest/Wildlife Officers from 01.09.2021 to 30.06.2022 – reg.

Sir/Madam,

You may kindly be aware that the Wildlife Institute of India, an Autonomous Institution under the Ministry of Environment, Forest and Climate Change, Government of India, has been conducting Post-Graduate Diploma Course in Advanced Wildlife Management for in-service Indian Forest Service and State Forest Service Officers of the rank of Deputy Conservator of Forests (DCF)/Assistant Conservator of Forests (ACF), Veterinary Officers and Forest Officers of equivalent ranks, who are engaged in managing natural forest resources particularly wildlife and protected areas. The course is designed to enhance the capacity of forest officers to effectively manage Protected Areas (PAs), Wildlife related issues outside PAs and conservation of endangered species. The course would abreast the participants in modern tools and techniques of Wildlife Management including preparation of scientific management plans for Protected Areas and forested landscapes.

The next ten months Post-Graduate Diploma Course in Advanced Wildlife Management is scheduled to commence from 01.09.2021 at Wildlife Institute of India, Dehradun. This Institute would like to get the participants for the said course from your State. This is a paid course and cost of per trainee is Rs. 11,00,000/- (Rupees eleven lacs only) and this cost will be borne by the concerned State Government/sponsoring agency. The Training Cost covers expenses to tuition fee, accidental insurance, field gears/equipments, stationary, books, study material, boarding & lodging charges, field exercise etc. The medical reimbursements of concerned Officer Trainees during the course will be borne by the respective State Governments, as per prevailing State rules.

It is also informed that during the period of course, the Institute will also organize an overseas study tour in addition to field tours within the country. But it depends on the guidelines issued by Govt. of India from time to time due to COVID-19 pandemic. Therefore, the applicant must be in possession of their valid passports with a validity period up to December 2022.

The candidates who are nominated for the course should have a minimum qualification of graduate degree in Forestry/Veterinary or allied subject with proficiency of English language. I would request you to kindly send nominations of forest officers in the enclosed application form from your State/UT for the said course preferably below the age of 45 years as on September 1, 2021. The nomination should reach to this Institute latest by 16th August 2021.
