FACULTY RECRUITMENT Advt. WII/ADM/2015-16/01

The Wildlife Institute of India is a premier national institution in wildlife research, conservation, training and management. The Institute is looking for bright candidates for filling up of Group-A Scientific positions 03 (three) posts of 'Scientist-D' on Direct Recruitment (D.R.) basis. The applications are invited from citizens of India for filling up of following posts:

Terms and Conditions:

- 1. The headquarter for the above post would be Wildlife Institute of India (WII), Dehradun. However, the selected candidate would be liable to serve at any location decided by the Institute as per functional needs.
- 2. **Age**: Not exceeding 35 years in case of candidates possessing Master's degree and 38 years in case of candidates having Ph.D. degree as on last date of receipt of application.

3. **Age Relaxation**:

Relaxation in upper age limit shall be allowed in accordance with the Government of India, Ministry of Personnel, Public Grievances and Pensions (Department of Personnel & Training) OM No.1501282/2010-Estt.(D) dated 27.03.2012 amended from time to time. However, the categories of upper age relaxations are as follows:

- (a) Scheduled Castes and Scheduled Tribes up to 5 years.
- (b) Other Backward Class (OBC) up to 3 years.

- (c) Widows, divorced women and women judicially separated from their husbands and who are not re-married up to the age of 35 year (up to 40 years for members of Scheduled Castes and Scheduled Tribes).
- (d) Employees of Wildlife Institute of India/ Central and State Government/ Autonomous Bodies/Government Universities up to 5 years to those who have not rendered less than three years of continuous regular service in such departments.
- (e) Up to maximum of 5 years to candidates of Jammu and Kashmir who have ordinarily been domiciled in the State of Jammu and Kashmir during the period from 01.01.1980 to 31.12.1989 (Any person intending to avail of the aforesaid relaxation shall submit the certificate from either District Magistrate within whose jurisdictions he/she had ordinarily resided or any other authority so designated in this behalf by the Govt. of Jammu and Kashmir to the effect that he/ she had ordinarily been domiciled in the State of Jammu and Kashmir during the period 01.01.1980 to 31.12.1989).

- 4. The Other Backward Class (OBC) candidates for the purpose of Age Relaxation and Reservation will mean "Persons of OBC category not belonging to the Creamy Layer" as defined in Government of India, Department of Personnel & Training OM No.36012/22/93-Estt. (SCT) dated 08.09.1993 and modified thereafter. Candidates claiming the benefit of reservation under OBC category not covered under the Creamy Layer must furnish the OBC certificate duly signed by the competent authority and self undertakingby the candidate on or before Closing Date (07.09.2015). Any deviation of the OBC Certificate from the prescribed format will not be accepted by the Institute and will lead such applications to be treated under Unreserved category, if they are otherwise eligible age-wise. Representations from candidates for reconsideration of their category at subsequent stages of the recruitment will not be The OBC (Non- Creamy Layer) candidates are required to submit requisite entertained. certificate in prescribed format (Annexure-1) of Government of India, from a Competent Authority issued and the same should not be prior to 01.01.2015. The name of the caste and community indicated in the OBC (Non-Creamy Layer) certificate must appear in the Central list of Other Backward Classes. No other format will be accepted.
- 5. The period of experience in the requisite discipline/area of work shall be counted with effect from the date of acquiring the prescribed minimum educational qualifications required for the post. Period spent in wildlife research/conservation/ training and management will be counted towards experience.
- 6. The job requires extensive traveling to forest interiors, wildlife areas, high altitude areas and arduous terrain.
- 7. Shortlisted candidates will have to produce original certificates cited in their applications at the time of interview, if called for.
- 8. Applications received after the due date i.e. **7**th **September 2015**, without application fee, incomplete applications and applications not in prescribed format will be rejected.
- 9. Candidates who obtain appointment by furnishing false information in the application are liable to be terminated.
- 10. The address for correspondence furnished in the application form is final and no request for change of address at a later date will be entertained.
- 11. Canvassing in any form will be a disqualification.
- 12. Mere fulfillment of the minimum advertised qualification and experience requirement DOES NOT automatically entitles an applicant to be called for written test/interview.
- 13. Last date of Receipt of application: The last date of receipt of application is 7th September 2015 up to 1700 hrs.

14. Selection Process:

- (i) The Institute shall screen the applications received by due date and organize a written test for shortlisting the candidates to be called for the interview. The test for the eligible applicants shall be conducted in the Institute campus at Dehradun on 24th September 2015 between 0900 hrs to 1430 hrs. The Written Test will be of two hours duration having 60 objective type questions. Each question will be of one mark each. There will be a negative marking of 0.25 marks for each wrong answer. The written test will start at 1000 hrs. onwards on 24th September, 2015. The Written Test will comprise multiple choice/objective questions based on the syllabus of Institute's M.Sc Wildlife Science Course. For syllabus, candidate may the Institute's see website at (http://www.wii.gov.in/masters wildlife 2 years and http://www.wii.gov.in/images/pdf/xiii msc syllabus.pdf). The candidates are required to report on 24th September, 2015 at 0900 hrs in the Institute's Auditorium located inside the campus.
- (ii) The first 20 candidates (for 02 Nos. posts of UR category) and first 10 candidates (for 01 post of OBC Category) in order of merit i.e. marks obtained in the Written Test will be shortlisted and called for Interview before the Institute's Selection cum Assessment Promotion (ISAP) Committee. The merit in written test is of a qualifying nature in the screening process to be called for interview. The final selection of the candidate will be in accordance with his/her performance in the interview and in order of merit as decided by the Institute's Selection Committee. The Interview of the Shortlisted Candidates by the Institute's Selection Committee will be held on 25th and 26th September, 2015 from 1430 hs. onwards in the Institute's Campus at Chandrabani, Dehradun.
- (iii) Candidates are requested to bring all documents in Original along with two passport size photographs along with self attested photo copies of all certificates while appearing for the Interview. In case of reserved category candidates, the original valid certificate should also be produced; failing which their candidature for the interview will not be allowed. Candidates of 'OBC Category' need to bring the latest certificate (2014-15) as required in Government of India rules.
- (iv) The result of the Written Test will be hosted on WII's website (<u>www.wii.gov.in</u>) on **24**th **September, 2015 (Evening)** and also placed on the WII's Notice Board on or before 1730 hrs.
- (v) The candidates therefore are advised to come prepared to be present in Dehradun for atleast 2 nights i.e. 24th to 25th September 2015 and to make their own travel and stay arrangements at Dehradun for the Written Test/Interview at their own cost. No TA/DA will be paid for appearing in the Written Test/Interview. Any misrepresentation or falsification in the application and documents submitted will lead to summary disqualification of the candidature.

- (vi) The documentation/certificates in case of the candidates who are called for interview will be checked/verified from the originals certificates between 0900 hrs to 1300 hrs. on 25th September, 2015. In case it is found that an attempt has been made by the applicant to wilfully conceal or misrepresent the facts and does not fulfill the eligibility criteria, his/her candidature will not be considered and will not be allowed to appear for the interview and in such an event no claim of whatsoever will be considered. Candidates are required to furnish the declaration form as given in the prescribed application form.
- 16. No correspondence will be entertained either with regard to call for written test, interview and/or selection.
- 17. It may be noted that if, at any stage, it is found that an attempt has been made by the applicant to willfully conceal or misrepresent the facts, his/her candidature may be summarily rejected and his/her employment terminated.
- 18. The date for determining the age limit/experience/qualifications shall be the closing date prescribed for receipt of applications i.e. **7**th **September 2015**.
- 19. The decision of the Institute in all matters relating to eligibility, acceptance or rejection of application, mode of selection will be final and binding on the candidates and no enquiry or correspondence will be entertained from any individual or his/her agency.

How to Apply:

- (i) The applications should be sent in the prescribed proforma (Annexure-2) typed out on A-4 size paper 210x297 mm) accompanied by crossed Indian Postal Order/Bank Draft of the value of Rs.1000/- (Rupees One Thousand only) drawn in favour of Director, Wildlife Institute of India, payable at Dehradun. Fee is non-refundable.
- (ii) Applications should be accompanied by self attested copies of certificates of age, educational qualifications, experience, and claim of belonging to OBC (Non-Creamy Layer). The original certificates would be required at the time of interview.

Applications should be sent to the Administrative Officer, Wildlife Institute of India, Box 18, Chandrabani, Dehradun–248 001 (Uttarakhand) so as to reach on or before **07.09.2015**. Applications from abroad and from those in the Andaman & Nicobar Islands, Lakshadweep, State/Union Territories in the North Eastern Region, Ladakh division of the Jammu & Kashmir State, Sikkim, Panaji Sub-division of Chamba, Lahaul & Spiti Districts of Himachal Pradesh should reach upto **14.09.2015**.
