1	<b>No. of Position &amp; Age Criteria</b>	Project Associate - 1 (1 post). Age: Upper age limit 35 years on the date of interview. Upper age limit in case of applicants belonging to Schedule Castes/Schedule Tribes/OBC may be relaxed as per the rules.
2	<b>Essential Qualification</b>	Masters' Degree in Natural or Agricultural Sciences from a recognized University or equivalent and having CSIR or UGC NET fellowship. The project has no provision of manpower budget
3	<b>Desirable Qualification</b>	Candidates should have good knowledge of bird identification and are familiar with research on birds.
4	<b>Description of Work</b>	This study focuses on understanding population and nesting ecology of House Sparrows across elevation gradients in the Uttarakhand State. And for this nest monitoring using nest boxes at select sites will be carried out. Additionally, this project includes a molecular component to study the genetic structure of house sparrow populations so as to identify presence of subpopulations and their evolutionary history in the Uttarakhand Himalaya. Further, the project includes an ecotoxicology component to investigate the presence of pesticides in house sparrows and possible correlation on the decline of the species in the State.
4	<b>Emoluments</b>	As per CSIR/UGC NET Fellowship (Rs. 31,000/- per month + HRA as admissible).
