<b>6</b>	<b>Description of work</b>	The study aims to determine the avian species diversity patterns, identify the determinants of bird species richness, habitat utilization pattern by birds, assess the effect of anthropogenic pressure and prepare a conservation plan for avifauna in Sahyadri Tiger Reserve.
<b>7</b>	<b>Age</b>	The upper age limit for Project Biologists shall be 32. Age relaxation: upper age limit is relaxable upto 5 years for SC/ST/OBC, Women and persons with disabilities
