Sir/Madam,

In continuation of my application dated 4/9/19 further following action/information is sought under RTI Act 2005. To this effect I have deposited a sum of Rs 10/- with cashier of W.I. as is required under the said Act vide W.I. Receipt No 15576 dated 5/9/19 :-

- ① No cognizance of Point A vide my application dated 4/9/19 under said Act may be taken. Instead A as follows may kindly be taken. Rest from B to D remains unaltered:
A A copy of OM No A/1/3-29/2010-W.I. dated 1/2/2019 highlighting therein the decision of the competent authority concerned that the redesignation of Post has been allowed only from 1/2/2019 (Ref: Para 7 of Office Communication No A/2-6/2009-W.I. dated 19/8/19)
B In view of implementation of Revised RRs-2019 w.e.f. 1/4/2006, my substantive post of Admn. Officer now as Deputy Registrar (Pay level Matrix-12 of Pay Rs 7600=00) becomes higher Post vis-a-vis to the post of Academic Officer (Pay level Matrix-10 of Rs 6600=00) to which I was ^{internally} transferred. The Post of Academic Officer has been kept in the feeder channel of Dy. Registrar. My substantive post of A.O. now as Dy. Registrar was also filled up by a Junior from the feeder channel of A.O. (Admn. Officer) during the currency of my holding the charge of ~~Admn.~~ Academic Officer whose even RRs were not in existence is now in higher Pay level Matrix and Post whereas I was kept in the lower Pay level Matrix and Post is paradoxical.

Therefore, following is requested for response:-

- (i) Provide a copy of Rules whereunder a holder of a substantive post can be internally transferred to a lower post, whose RRs were not even in existence.
- (ii) Provide a copy Rules whereunder internal transfer to a post results into vacation of the substantive post to be filled in by Junior from the feeder channel.
