1.	How many subordinate offices/Departments have notified Recruitment Rules for the official Language Cadre as per the Model Recruitment Rules issued by DoPT.	The Institute has one post of Hindi Translator in PB-2 (9300-34800) with Grade Pay of Rs.4200. Recruitment Rules for this posts have been framed on DoPT guidelines and notified with other posts of Administrative Cadre vide Notification No. A/1-3/XLVII/GB/WII (RRs) dated 01 <sup>st</sup> August, 2007 (copy attached as Annexure-1). 
2.	What action has been taken in this regard by the concerned Offices/Departments till dated according to Model RRs.	The post of Hindi Translator has already been filled up.
3.	Has DoPT issued any reminder to concerned ministry/departments regarding compliance of the above Model RRs.	No such reminder received by the Institute.
4.	Is Indian Audit & Accounts Department comes under Subordinate Offices/Department.	The Institute is an autonomous organization under MoEFCC, Government of India.
5.	Should the Post of Hindi Officer in Subordinated offices be re-designated as Assistant Director as per the above mentioned Model Recruitment Rules.	There is no sanctioned post of Hindi Officer in this Institute.
6.	What is the criteria of creating Official Language Posts above Hindi Officers/Asstt. Director if the total number of staffs in subordinate offices are more than 30 thousands.	Not applicable in case of Wildlife Institute of India. As the total strength of staff is less than 167.
7.	Is there any monitoring cell/agency functioning for Official Language Cadre in Subordinate Offices.	Not Applicable in case of this Institute. However, a departmental Committee on official language has been constituted to look after use of Hindi Language (Rajbhasha) in official work.
